## Quarterly CEO Report

The Code Enforcement Office continues to update and archive historical building and plumbing data into our computer database. The ability to quickly search out old permits and applications for property owners, attorneys, realtors, and historical research is such a time saver. All permit applications since mid-2019 are created using the Code Enforcement software. The program provides a clean printable permit and application.

So far this year the building boom that we had last year is waning, but small projects are ongoing.

The quarterly data is attached.

Phase II of the Lovell Self Storage conditional use application is still on hold until the Maine DEP decides on the Stormwater and Erosion Control plan and permit.

I was able to update the Lovell Zoning Ordinance Manual in-house, saving the Town about 50% in printing costs. The new update includes the solar ordinance and the new Article 6.2 verbiage. It was pointed out to me after updating the manual online that I missed the LSSES Commercial Industrial "C" and APO footnote #5 designation on page 29. These were immediately corrected.

The fee for a hardcopy of the Zoning Ordinance manual is \$20.00.

A new Shoreland Land Use application is now available online and at the Town Office. The Shoreland Land Use application shall be used for all future building and land use requirements that are inside the 250-foot Shoreland Zone. The application along with all other building and plumbing permit fillable applications can be found on the Code Enforcement page of the website.
